



ICFRE-Tropical Forest Research Institute, Jabalpur, MP is a premier research Institute under ICFRE (Indian Council for Forestry Research and Education) an autonomous Council under the Ministry of Environment, Forest and Climate Change, Govt. of India, New Delhi.

The competent authority (Director, ICFRE-TFRI) has decided to select candidates in pursuance of Advt no. TFRI/JBP/DR/2025, dt 14/07/2025 based on the merit list provided by MPonline.

If your name appears in the merit list below, have necessary educational qualifications, meet the age criteria as on 01.07.2025, and willing to join the document verification process for the posts at ICFRE-TFRI, Jabalpur, please be physically present along with mandatory original documents of Essential educational qualification, No objection certificate (N.O.C) from the employer, Experience certificate for the post of Driver and caste & income certificate (as applicable) issued by the competent authority in case of Scheduled Caste/Tribe/Other Backward Classes/Economically Weaker Section/ Divyangian /Ex-servicemen. Kindly also bring a valid photo ID for personal identification and one recent colored photograph and 02 set photocopies of above mentioned documents for verification on 28.11.2025 at 10:00 AM at ICFRE-Tropical Forest Research Institute, PO-RFRC, Mandla Road, Gaur Tiraha, Jabalpur 482 021 (M.P.) A common merit list of all the candidates who successfully meet the above conditions after document verification shall be prepared (For the post of Driver/Forest Guard after qualification in physical and skill test on 29 November 2025).

The candidature of candidates who appear for document verification but failing to appear for the physical/skill test on 29 Nov 25 shall be summarily rejected and not considered later at any stage of recruitment. A separate notice has already been issued for the above physical & skill test.

Kindly note that the notice for document verification does not confer any right for employment.

#### **General instructions**

- 1. All disputes related to recruitment shall be subject to the Jabalpur Jurisdiction only.
- 2. The interested candidate may please reply immediately to the email on **tfrirecruitment2025@gmail.com** before 25<sup>th</sup> November, 2025.
- 3. If the candidate **fails to be physically present** on the designated time and place **along with all the necessary documents**, his/her candidature shall be summarily rejected and shall not be considered later at any stage **under any circumstances**.
- 4. The appointment is purely on temporary basis until further orders and will not confer any title to permanent employment. The candidate will be on probation for a period of two years from the date of appointment and the probation period may be extended, as per rules, by the appointing authority.
- 5. All other terms and conditions of the service will be governed by ICFRE from time to time.
- 6. If the candidate is already employed, he/she would produce a **No objection certificate (N.O.C) from** the employer without which his/her candidature shall not be entertained.
- 7. Kindly note that the appointment will be provisional and will be subject to verification of the Schedule Caste/Schedule Tribe/OBC/Divyangjan/EWS Certificate, if applicable through proper channels and that if the claim to belong to SC/ST/OBC/Divyangjan/EWS is found to be false at any stage, the services will be terminated forthwith without assigning any reason and without prejudice to such further action that may be taken under the Bhartiya Nyaya Sanhita 2023 for production of false certificates.
- 8. If any declaration given or **information furnished by the candidates proves to be false** or if they are found to have willfully suppressed any material/information, they will be liable for removal from service and such other action as Govt./Council any deem necessary.
- 9. The appointment will be governed by the new Defined Contribution Pension Scheme (NPS) of this Council i.e., Indian Council of Forestry Research & Education.
- 10. The offer is subject to Police verification and character antecedents, which if found false at any later stage, you will be liable for **removal from service** and such other action as Govt./Council any deem necessary.
- 11. The Headquarter of the MTS post shall be ICFRE-Tropical Forest Research Institute, **Jabalpur** or ICFRE-SDC, **Chhindwara** (Madhya Pradesh). However, the appointment carries with it the liability to serve anywhere in India.
- 12. No TA / DA will be granted / allowed for Document Verification and skill test on dated 28 and 29.11.2025 at ICFRE-Tropical Forest Research Institute, Jabalpur.
- 13. Caste & income certificate (as applies) issued by the competent authority in case of Scheduled Caste/Scheduled Tribe/Other Backward Classes/Economically Weaker Section/Divyangjan/Exservicemen must be in the latest format as prescribed by the central govt. (attached).
- 14. If the above mentioned documents are available with the candidate in digilocker, kindly download them before coming to this institute.
- 15. The Director, ICFRE-TFRI reserves the right of not filling up the post of above mentioned without assigning any reason whatsoever.
